SECTION 4: First aid measures

4.1. Description of first aid measures

General information

for disposal in appropriate containers in accordance with the local regulations (see chapter 13). Use appropriate container to avoid environmental contamination. Fouled surfaces must be immediately cleaned with suitable solvents, Useable as such (flammable): water 45 vol.% ethanol or i-propanol 50 vol. % ammonia solution (density= 0.88) 5 vol.% Alternative (non-flammable): sodium carbonate 5 vol.% water 95 vol.%.

7.1. Precautions for safe handling

Advices on safe handling

Avoid formation of flammable and explosive vapour concentrations in the air and exceeding the exposure limit values. Only use the material in places where open light, fire and other flammable sources can be kept away. Electrical equipment must be protected meeting the accepted standard. Product may become electrostatically charged. Provide earthing of containers, equipment, pumps and ventilation facilities. Anti-static clothing including shoes are recommended. Floors must be electrically conductive. Be careful when opening used containers (excess pressure). Precautionary measures should be taken in order to reduce strain from humidity or water: CO2 is formed which may produce excess pressure in closed containers . 8.2. Exposure controls

Practical experience/human evidence

Other observations:

Inhaling of solvent components above the MWC-value can lead to health damage, e.g. irritation of the mucous membrane and respiratory organs, as well as damage to the liver, kidneys and the central nerve system.
